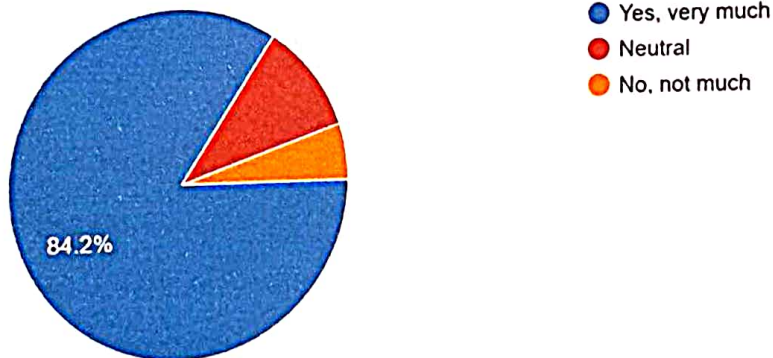

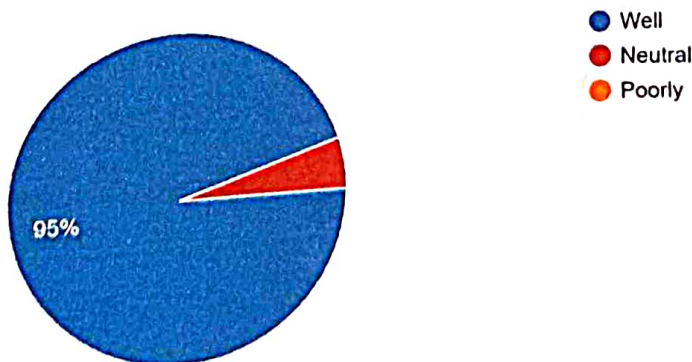
1. How effective were the teaching methods and materials used during the FDP?

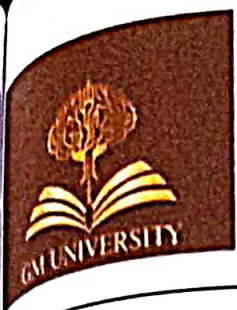
2. Did the FDP provide you with practical tools and strategies for writing course outcomes?

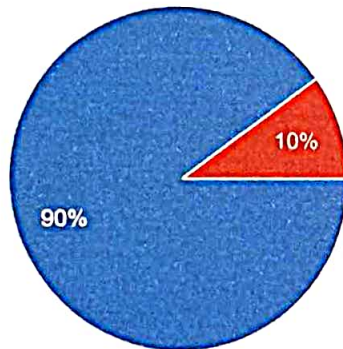

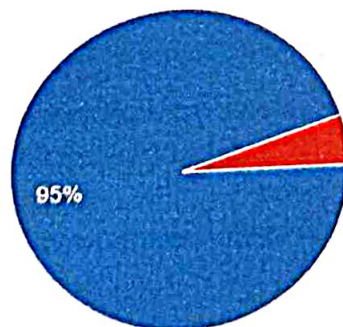

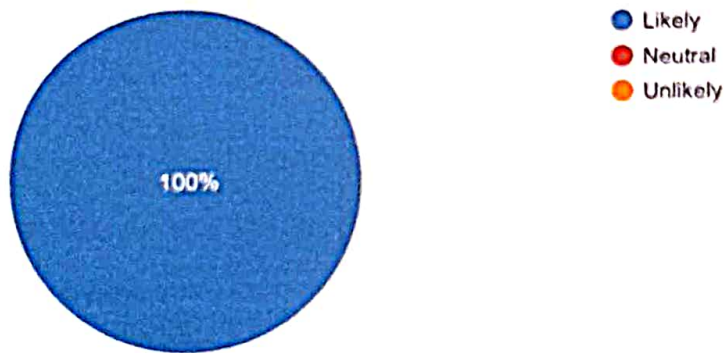

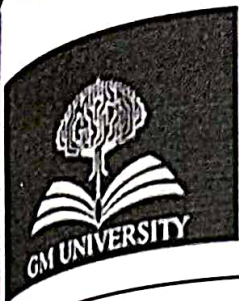
8. How likely are you to apply the knowledge and skills gained from the FDP in your own course design?
